Nominee – Jason Baldrige
Academic & Career Accomplishments
RHS Graduation Year 1992
Currently lives in Mountain View, CA.

After graduating from Rockford in 1992, Jason earned a full-ride Presidential scholarship to attend the University of Toledo, Ohio. He began studying Mechanical Engineering while minoring in Anthropology. After traveling to India and participating in an archaeological dig in Berenike on the Red Sea coast of Egypt (see http://www.jasonbaldridge.com/berenike), Jason switched his major to Anthropology. He took several linguistics classes and discovered that the field of computational linguistics perfectly joined his interests in both the sciences and the humanities. As a graduate student at the University of Pennsylvania, he discovered a passion for machine learning and formal, mathematical models of human language grammar. After completing masters degrees in Linguistics and Computer Science in 1998, Jason moved to Scotland and earned his PhD in Informatics at the University of Edinburgh. His 2002 dissertation on universal grammar using linear logics won the 2003 Beth Dissertation Prize (https://en.wikipedia.org/wiki/E._W._Beth_Dissertation_Prize). During his PhD, Jason also created the open source OpenNLP software package, which provided natural language processing capabilities based on machine learning. It became a widely used package in both academia and industry and is still being actively developed and used as part of the Apache Software Foundation (https://opennlp.apache.org/), over two decades after its inception.

Following his PhD, Jason did a postdoc at the University of Edinburgh, which focused further on machine learning and parsing for both sentence and discourse structure. In 2005, he joined the University of Texas at Austin as an assistant professor in the Department of Linguistics, where he spent over a decade researching linguistics and natural language processing. Jason also consulted with companies on applications of natural language processing, especially sentiment analysis. After earning tenure, he co-founded People Pattern, a start-up focused on machine learning and natural language processing for major brands to better understand their social media audiences. In 2017, he joined Google Research and now leads a team tackling grounded language understanding in Austin, Texas. His research focuses on using neural networks for representing language and images and using them for problems such as retrieving and generating images based on descriptions and learning computational agents that can follow and give instructions in 3D simulations. Jason is an internationally recognized scholar who has written around 90 articles during the course of his career.

Jason married his amazing wife, Cheryl, in Texas in 2006. He has four wonderful children: Olivia (16, from his first marriage), Nash (11), Gray (7) and Esme (2). Jason's family fills him with love and joy -- and keeps him grounded in the real world while he also pursues his research into language and how we can model it in computers. His incredible parents, Fred (a calculus teacher at Rockford High School) and Mary (an artist in Michigan), have supported him throughout his entire life and have proven themselves to be remarkably fun (and popular) grandparents. Other family, friends and colleagues--too numerous to list here--have provided enormous support and inspiration at every stage of his life. In fact, this short biography tells a somewhat tidy story to what is actually a constant renegotiation of Jason's career and

Nominee – Roselle (Chilson) Havens Honorary Achievement Currently lives in Middleville, MI

Roselle Havens, former Teacher, Principal, and Director of Special Education Services for over 25 years of service to the students, parents, staff and community of Rockford Public Schools. Some twenty years after her first days in the Parkside Elementary classroom, the region and the state began to recognize her career achievements as a master of innovation for students in both general and special education programs. She was granted the 1984 Michigan Elementary and Middle School Principals Region 9 Leadership Award. That same year, the River Valley Math Program was chosen from over 150 programs submitted to the US Department of Education, cited as an example of excellence in math instruction to be used as model for schools throughout the country. Two years later, she received the General Educator of the Year Award from the Region 1 Parent Advisory Council for Special Education; and in 1987, the Michigan Association of Children with Learning Disabilities Award of Excellence.

Roselle Havens retired in 1988. In acknowledgement of her uniquely notable service, she received letters of commendation from then-President Ronald Reagan; the US Secretary of Education William Bennett; and a State of Michigan Special Tribute from State Representative Victor Krause. While those tributes currently hang in her home office, she has a number of scrapbooks stuffed with letters of praise and gratitude from parents, students, fellow educators and administrators. And it was hard for her to leave behind the career that had given her so much satisfaction.

She actually returned to the school district in 1989 to resume the principalship of River Valley. She retired for a second time in 1991. The Rockford Board of Education acknowledged their gratitude for her remarkable dedication to the district with the Meritorious Service Award. Her colleagues in the Michigan Elementary and Middle School Principals Association in Region 9 awarded her with an Outstanding Service Award.

Nominee - Jim Haskins

Honorary Achievement

Currently lives in Grand Rapids, MI

Jim Haskins served as the principal of Rockford High School for fifteen years. He came to Rockford High School as an assistant principal in 1983 after spending the first seventeen years of his career as a teacher, coach and administrator within the Grand Rapids Public Schools. After one year as an assistant at Rockford High School, he became the head principal in 1984. He proceeded to guide Rockford High School through years of unprecedented growth, instilling the high standard of excellence that drives the school to this very day. Jim was also very instrumental in the development of the new high school building that opened in 1993. The following year Rockford high School was recognized as a National Blue Ribbon School and was selected as one of the top technological high schools in the country. RHS was the first high school in the country to have voice, video and data to all classrooms. In addition, video conferencing, multi-media capabilities, distance learning and satellite uplinks were also introduced. The high school boasted the first Tech Ed department, which replaced Industrial Arts, as well as opened the first TV studio to our area. The school became the benchmark for schools throughout the United States and the world. They hosted 18,000 visitors from throughout the United States and numerous foreign countries.

Mr. Haskins introduced and implemented the Academic Letter award to recognize academic excellence. He also spearheaded changes to the National Honor Society programs. At the state and national levels, he was very involved in committees related to academic programs for secondary schools.

After retiring from Rockford in 1999, Jim went to work for Greiner Architectural Firm that had designed the high school. He became a certified project manager and oversaw technology design for numerous high schools in Michigan and the United States. His management skills led him to be promoted to the Midwest Regional Communications and Technology Manager for the corporation. This role led to involvement with intelligent transportation systems in numerous states and medical technology related to the expansion of the Medical Mile in Grand Rapids and the Secchia Center.

In 2005, Jim became the first commissioner of the OK Athletic Conference which is composed of 49 schools. The OK Conference is the largest athletic conference in Michigan and perhaps the country. He directed the league for fourteen years, providing much needed direction and credibility for the conference. Jim introduced software technology for scheduling games, officials and officials' pay. He worked on the VNN system to report conference scores to news media and conference schools. Rockford currently uses this system for athletic communications. His career in total spanned 48 years in education and local athletics. Jim is still a fixture at RHS home games and other activities in Rockford where his grandchildren are involved.

Nominee – Paul Krupp
Service to the Community
RHS Graduation Year 1972
9.19.54 – 9.1.18 deceased

The late Paul Krupp and his wife Nancy own and manage Krupp Farms which has been in his family and serving the community for over a century. It is an iconic landmark known to thousands of people who come from all over the region each summer to pick or buy strawberries, raspberries and asparagus. Paul especially loved children, so it is not surprising that Krupp Farms includes a playground and an ice cream shop.

Paul was an involved, respected member of the community, and was well known for his exceptional service and generosity. He was a member of the Rockford Lion's Club, Assumption BVM Catholic Church, Rockford Area Museum and North Kent Connect. He and Nancy also own the Antor Travel Agency, arranging and hosting many trips abroad for hundreds of people over the years.

Claire Guisfredi, Executive Director at North Kent Connect, said that Paul was the consummate fundraiser and a true ambassador. "He was passionate about the ministry at North Kent Connect and was a key person on our building campaign committee."

Al Pratt, Co-Director of the Rockford Area Museum, spoke glowingly about Paul's generosity as well. "Paul was extremely important in the creation of the Rockford Area Museum. Without his help with the major fundraising, the museum may have never happened."

To many Paul seemed larger than life, yet he was always selfless and thoughtful. And he was always willing to help a friend, or his community, in times of need.

Nominee – Dr. Jeffrey VanWingen MD

Dr. Jeffrey VanWingen graduated from Rockford High School in 1989. Following, he attended The Lyman Briggs School of Michigan State University, graduating in 1993 with a degree in physiology, interdisciplinary studies in health and humanities. He was selected as MSU Senior of the Year for the 1992-93 school year. Aside from studies, Dr. VanWingen played tuba in the marching band during his undergraduate years. He received his MD from the Michigan State University College of Human Medicine in 1997. Currently lives in Montreal, Canada moving to Grand Rapids, Mi (soon)

George Goad graduated from Rockford High School in 2009. He began his musical training on the trumpet at North Rockford Middle School under Cullen McCarthy, and at Rockford High School under Brian Phillips. He had private tutelage under Aaron Good and Greg Good while in middle and high school. In addition to activities in the band programs at Rockford, George was a member of the St. Cecilia Music Society's Youth Philharmonic and the Grand Rapids Youth Symphony.

He was admitted to the prestigious Curtis Institute of Music to study with David Bilger, principal trumpet of the Philadelphia Orchestra. He graduated in 2013 with his Bachelor's degree. He went on to pursue a Master's degree from the Shepherd School of Music at Rice University, graduating in 2015. While at Rice, he studied with legendary teachers Barbara Butler and Charlie Geyer. During summers, George was selected to participate in the National Repertory Orchestra (Breckenridge, CO) and the Tanglewood Music Center (Lenox, MA).

Following his college studies, George was accepted into the New World Symphony, a training orchestra for young people in Miami Beach, Florida. World-renowned maestro Michael Tilson-Thomas founded and leads the organization. The program consists of community outreach, innovative concert settings, and workshops to help musicians navigate their careers beyond the practice room and concert hall.
